

Kindergarten - Yr 2 Acceptable Usage Agreement

The school rules are set out below for when a student uses computers, iPads, all associated technologies, the internet, or an online account:

EQUIPMENT:

- 1. I will use computers and iPads only with permission.
- 2. I will be careful not to damage school equipment.
- 3. I will not change the computer or iPad settings unless I am given permission.
- 4. I will follow all instructions from teachers when using computers and iPads at school.

SECURITY & PRIVACY:

- 1. I will keep my passwords private and not share with other students.
- 2. I will not let other people logon and/or use my online account.
- 3. I will tell the teacher if I think someone is using my online account.
- 5. I will tell the teacher if I see anything that makes me feel uncomfortable or unsafe, or that I know I should not access or view at school.
- 6. I will say where other people's pictures of words come from if I copy them from the internet.
- 7. I will not use school services to be mean, rude, or unkind about other people.
- 8. I will check with the teacher before giving information about myself or anyone else when using online services.

Kindergarten - Yr 2 Request for access to third party service

Dear parents and caregivers,

We are writing for approval for your child to access online third-party services to support their learning in the classroom. The services are provided by third party vendors and are not managed by the Department of Education. Each of the third-party services have been assessed by the Department as approved for use in WA public schools.

To implement them we need to provide some personal information about your child, and we are seeking to gain your consent to do so. The information provided to third parties varies between the different providers. The personal information provided is listed below each individual service for your convenience.

When providing consent, it is important that you are aware of what type of information we will be providing, how it will be used, and where it will be stored. If you do not provide consent, your child will not have access to the third-party online services.

The online services provide our students with significant education benefits. The school will contact you to discuss your reasons should you not consent or fail to provide a response. If you do not consent, your child may receive an alternative education program that does not make use of these services.

Please note that **no parent action** is required for these online third-party services. The school is required to inform you of the use of these services, but you are not required to provide consent.

If you have any concerns about these services, please contact the school directly.
